

# Community Characteristics Insights

## Interviewees consistently cited Nicholtown's history and people as its greatest assets.

The community-and-values oriented **spirit of Nicholtown** and its residents is consistently discussed as the community's greatest asset. This includes strong commitment to the community and neighbors, resilience through challenges, and optimism, hope, and a vision for making sure that Nicholtown's history is preserved and is a great place to live.

The leaders, advocates, and strong networks of people in the Nicholtown community have been noted as a top strength.

Nicholtown has a rich history and is one of the oldest African American communities in Greenville.

I believe that anything's possible when this community gets behind it.

There are generations of families from this community spanning more than 150 years back.

Nicholtown Neighborhood Association has key leaders who are staunch advocates for their community.

# Other strengths included community supports and relationships, access to or desire for resources, economic growth, and infrastructure.

Strong community ties and church groups.

In recent years, the neighborhood has gone through reform with new houses, remodel flips, and beautifying parks and other areas.

The Nicholtown area is more walkable than other parts of Greenville County and is closer to the city of Greenville and there is a lot of park and trail infrastructure.

Community has a desire for more resources and wanting more information.

Nicholtown is centrally located close to resources.

Strong police presence in a way that isn't as detrimental as what we might otherwise see (e.g., targeted police action).

- Impacts of economic growth and gentrification (e.g., affordable housing, living wage employment)
- Infrastructure investments (e.g., sidewalks throughout the community)
- Juvenile crime
- Opportunities to engage parents and families
- Relationship building / trust (e.g., police relationships, connection across residents)
- Resources (e.g., awareness / information dissemination, use of resources, more resources)
- Understanding of the community / additional advocacy
- Youth programming and engagement opportunities




## **Crime Rates Over Time**

Rates per 1,000 (2019-2022)



Part I. Violent Crime




Part I. Property Crime





# The top five incident types in the past year, excluding "all other" and "traffic incidents", are:


- Drugs / Narcotics Violation (151 incidents,16.1%)
- Theft (102 incidents, 10.9%)
- Assault Simple (94 incidents, 10.0%)
- Burglary from Motor Vehicle (62 incidents, 6.6%)
- Vandalism (55 incidents, 5.9%)

- Drugs / Narcotics Violation make up about 16.1% of all incidents in the past year.
- About half (49%) of violations were related to marijuana, followed by about 18% that were related to "narcotics investigations" that did not specify a drug type.
- The most common locations for drugs / narcotics violations were Highway / road / alley (91); Residence / home (17); and Government / public building (11).



- While weapons violation incidents were not among the top five most common incidents, representing about 5.1% of all incidents, one interviewee referenced that the young people they work with have shared their fears of "violence and guns."
- The interviewee noted that violent crime is a downstream impact of multiple and interrelated factors, saying "... having a gun is a consequence of lacking opportunities in other spaces."
- The most common locations for weapons violation incidents were Highway / road / alley (18); Residence / home (11); and Apt. / condos / duplex (11).





# Community Safety Strategy Team (CSST) Prioritization of Needs

### Where are we now?



#### **VOICES Mission**

The CSST and WestEd are implementing the VOICES Project in Nicholtown to create a more cohesive and safe community. The VOICES Project will strive to be transparent with the community and inclusive of all voices, share and distribute data and information, build relationships across differences, and focus on the prevention of crime by redressing harms that have impacted the community.

**Mission:** To improve community safety for Nicholtown residents by addressing existing impediments to community empowerment and by supporting connections to necessary services and treatments.



## CSST members engaged in an activity to prioritize needs based on two criteria.

Impact: If this need was addressed, what impact would it have on improving community safety in Nicholtown?

**Feasibility:** Given scope, time, cost, and other resources, how feasible is it for VOICES to address this need?

- Scope: To what extent does the need fall under a "community safety" umbrella? Is this a need that VOICES has the capacity and authority to address? Would this need be better addressed by another agency or partner in Greenville?
- Time: Can this need be addressed within the timeline of the VOICES project?
- Cost / Other Resources: Does VOICES have the financial resources to address the need? What about staff needs, required partners, or training needs?



#### Reflection

- The needs rated with the highest impact on community safety, while retaining a high feasibility score, were supports for areas with high crime and family focused services and engagement.
- The needs rated with the highest feasibility score, while retaining a high impact score, were youth engagement, programs and supports and awareness and use of community resources.
- CSST members discussed that top four needs are deeply connected, expressing a desire to focus on prevention efforts with youth and families through the VOICES project.
   Additionally, they noted that the remodel of the Nicholtown Community Center provides a perfect opportunity to align VOICES with existing investments.

"Right now is a very good time to address youth engagement with the remodel of the center... It begins at home. We have to develop programs while they are young for prevention and with the family... Start with the family and youth and the community and make them aware of awareness of resources and services."

"Supports with areas for high crime is more than suppression from law enforcement, but a focus on diversion and prevention programs. As we start to share resources and services, it starts to build relationships and the use of resources."

"All of the need areas are connected. For example, just looking at the family focus will impact high crimes... I love the holistic approach."
